Agreement: This agreement is between you, the subscriber of the Service, and Maskcom.ca. By creating an account with and using the Service, you agree to be bound by these Terms and Conditions and our Acceptable Use Policy (available at <http://www.maskcom.ca/aup.html>) (the "Agreement"). This Agreement may be changed by Maskcom.ca at any time. Prices are guaranteed for an initial 12 month period only. Any changes to this Agreement will be posted on the Maskcom.ca Website. If you disagree with the changes you accept that your sole and exclusive remedy is to stop using the Service and notify Maskcom.ca that you are terminating the Agreement. Your continued use of the Service after changes to the Agreement acknowledges your acceptance of the changed Agreement.

Service: Maskcom.ca cannot guarantee upload or download speeds. The speed will vary depending on location, weather, wiring, internet traffic, content of a particular website, as well as overall performance and configuration of your computer.

Installation: Only Maskcom.ca installers may install the equipment. You are responsible for all costs due to the inside and outside wiring and mounting of the system. Should service be unavailable at your location, your account will be charged \$50 which will be applied to your first bill when service becomes available. Maskcom.ca, its agents, employees, representatives, or contractors have no liability for any damage to or loss or destruction of any of your hardware, software, files or data. It is your responsibility to backup all existing files. This document allows access to Maskcom.ca's service plans. To achieve proper connectivity to our network a subscriber must have the required equipment and a system professionally installed and meeting minimum system signal levels as determined by Maskcom.ca. The ability to achieve those levels and the required site service is solely the responsibility of the subscriber.

Radio Use and Responsibility: In order to receive the Service it will be necessary for you to lease an approved transceiver (CPE) from Maskcom.ca. The Customer is responsible for the safety and security of the wireless equipment. Should leased equipment be stolen or damaged, the customer will be required to pay for applicable equipment replacement and installation costs beyond that of "normal" wear and tear. The Customer is advised not to move or tamper with the Service and equipment once the installation is completed. Line-of-sight to the signal transmitters (towers or relays) must be maintained. Your CPE contains certain components and software, which are proprietary to Maskcom.ca and/or its vendors. You agree that you will not try to reverse-engineer or disassemble any software or hardware contained within your wireless equipment. Such actions are strictly prohibited and may result in the termination of your Services and/or legal action. Maskcom.ca warrants that your wireless equipment leased from us is free of defects in material and workmanship for the term of your contract. Maskcom.ca reserves the right to void a warranty and/or make reasonable changes for repair of a unit if the warranty seal is broken or the unit displays evidence of misuse, abuse, or tampering. Normal time frame for replacement is 7 days from the time it is resolved defective.

Term: This Agreement is effective as of the date your account is created with Maskcom.ca and the Service is activated. The initial term is 12 months. After which time has passed you will be renewed automatically on a monthly basis.

Cancellation: If you would like to cancel before the end of your contract term you will be charged an Early Termination Fee. The Early Termination Fee is the remainder of the Term (the monthly fee for your selected Service plan times the number of months remaining) or a \$100 Early Termination Fee, whichever is the lesser amount. After the initial 12 month term one month's notice will be required for cancellation. Requests for cancellation will not be processed unless the request is received by Maskcom.ca in writing. If these Terms and Conditions are not followed Maskcom.ca has the right to terminate the Service without notice and without any liability whatsoever.

Changes: Any changes you request to your Service are subject to a \$15.00 processing fee, including email changes and service level changes. The fee will not apply to your first change in any 2 month period.

Seasonal Hold: Requests for seasonal hold must be received by Maskcom.ca in writing and can be requested once per calendar year of your contract. Service will be charged at a rate of \$5/month during hold period (plus radio rental fee of \$9.99). Reactivations are subject to a \$25 fee. Service will automatically be reactivated and billed six months after the hold is requested. Period of time service is on hold will be added to contract end date to complete minimum 12 month contract term. Minimum of two business days may be required to reactivate service.
